**ABOUT THE AWARD**

**Recording for the Blind & Dyslexic (RFB&D)**, a nonprofit volunteer organization, is the nation's educational library serving people who cannot effectively read standard print because of visual impairment, dyslexia or other physical disability. Our mission is to create opportunities for individual success by providing, and promoting the effective use of, accessible educational materials.

Each year, the **Marion Huber Learning Through Listening (LTL<sup>®</sup>)** awards are presented to RFB&D members who are high school seniors with learning disabilities, in recognition of academic excellence, outstanding leadership, and service to others.

Marion Huber made her first gift of \$200 to RFB&D in 1959. By 1990, she was making gifts in the range of \$20,000. Marion was particularly focused on RFB&D's expanded mission, reaching out to students with learning disabilities. She observed the power of "Learning Through Listening" to transform lives, and it was for this reason that she endowed our award for students with dyslexia and other disabilities that prevent effective reading. By creating a permanent endowment, Marion Huber ensured that the work she valued during her lifetime continues today.

Offered since 1991, the awards are given to six students who are chosen by a selection committee. RFB&D presents the three top winners \$6,000 each and three special honors winners \$2,000 each. The three top winners will be presented with their awards at an event to be announced.

**Applicants should be aware that:**

- As a top winner, you must be present at the celebratory event in order to receive your award.
- All winners may be asked to represent RFB&D as a spokesperson and advocate at various local and national events. Costs associated with these events will be covered by RFB&D.

**APPLICATION INSTRUCTIONS**

Only fully completed applications will be considered for the awards. Please **DO NOT** include further information (such as news clippings, photos or additional references) other than that which has been specifically asked for. Such information will not be considered and will not be returned.

**Documents must be paper-clipped together (do not staple) in the following order:**

- A fully completed and signed personal application (*Form 1*)
- Essay – with your name at the top of each page
- List of honors, achievements and community activities
- Two letters of recommendation on official school letterhead with two signed referral forms (*Form 2*)
- An official school transcript

**DOCUMENTATION REQUIRED TO APPLY**

Candidates that meet all of the eligibility criteria must submit the following documents:

1. **A fully completed and signed personal application (*Form 1*)**
2. **One Essay:**  
  
Provide us with an essay of 1,000 words or less that includes all of the following:
  - Tell us about yourself and your life, including what you consider important about your background and your future personal and professional aspirations.
  - How and when did you discover RFB&D?
  - What difference has RFB&D made in your life and what role will it play in your future?
  - What role could you play as an RFB&D spokesperson and advocate?
3. **Honors, achievements and community activities:**  
On a separate sheet of paper, list and describe the following:
  - Honors, awards and honorary society memberships.
  - Special achievements (scholarships and talents).
  - Extracurricular and community activities. Please provide timeframes and the extent and level of involvement.
4. **Two letters of recommendation for this award** from teachers or school administrators who have known you personally and can evaluate classroom performance and extracurricular activities. Attached to each letter of recommendation must be a referral form (*Form 2*) signed by the teacher/school administrator. The letters ***must*** be on official school letterhead.
5. **An official transcript** of your high school grades at the time of application, covering grades 10 through 12. *All transcripts must include some grade 12 marks.*

- I am a member of the 2010 graduating class of a public or private school or home school in the United States or its territories, including U.S. military installations
- I have an overall grade average of B (i.e. 3.0 out of 4.0) or above, based on grade levels 10 through 12 at the time of application
- I plan to continue my formal education beyond high school at either a two- or four-year college or vocational school
